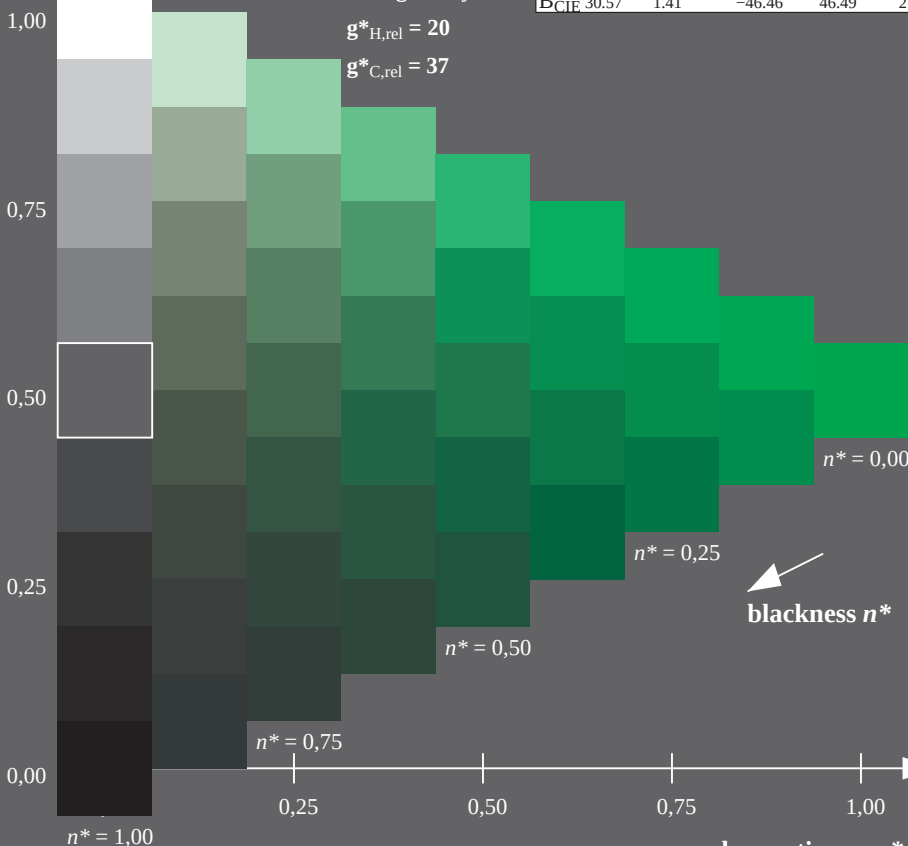

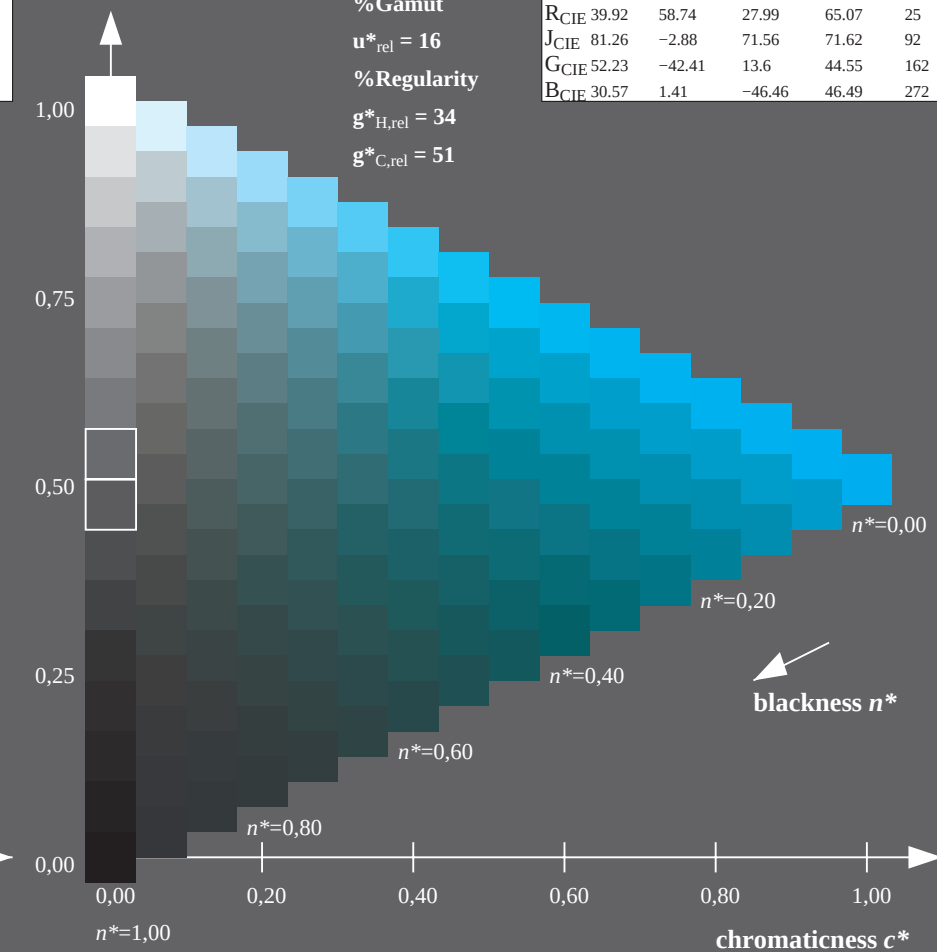


OE930-7, 9 step scales for constant CIE LAB hue 196/360 = 0.545 (left)

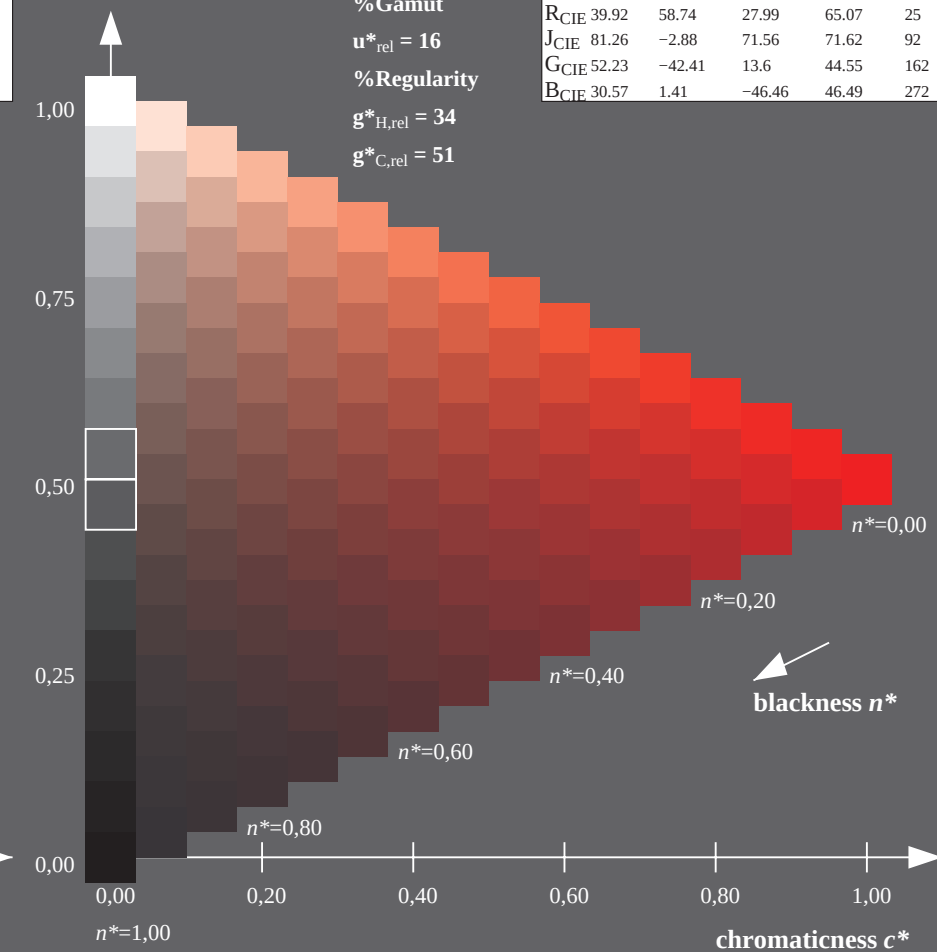

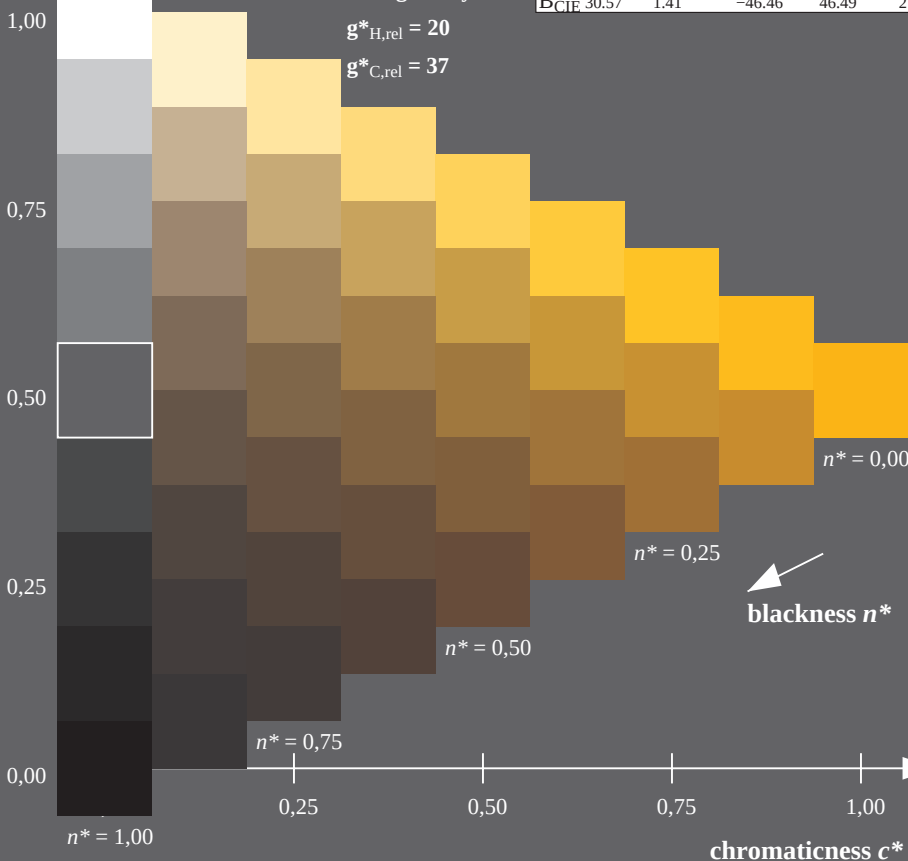

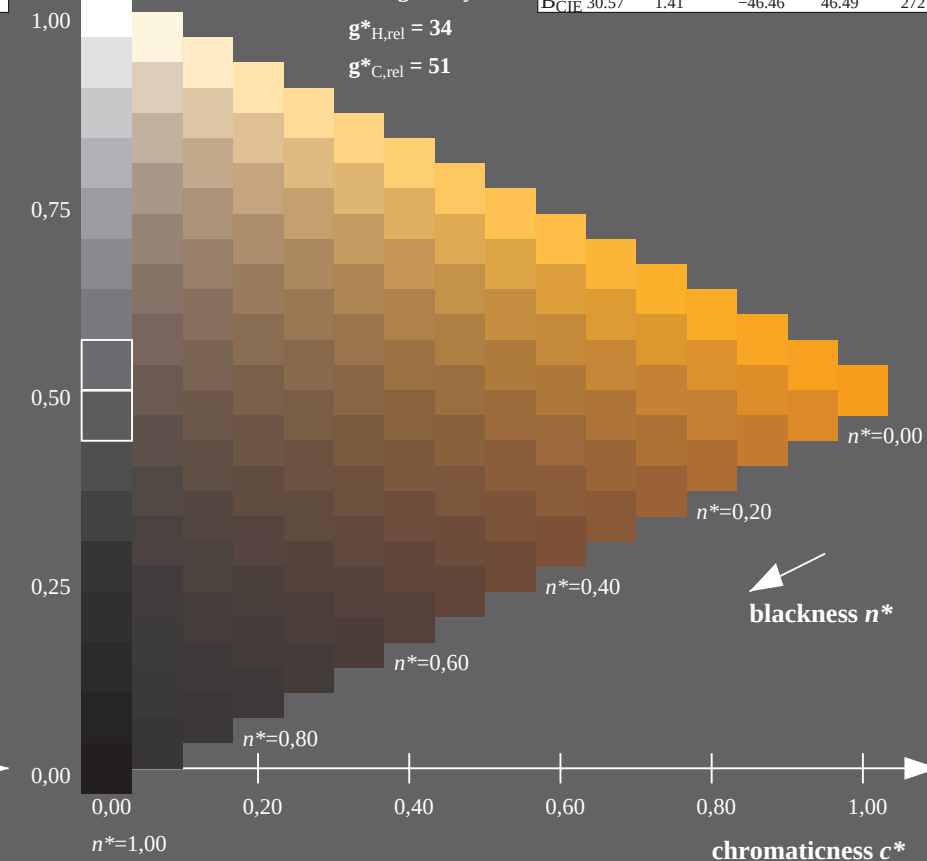

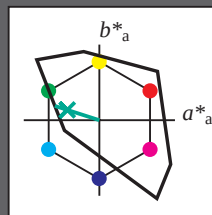

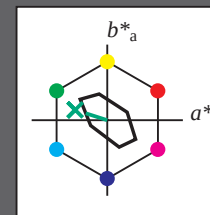
